JUNIOR GROUPS EFT POLICY

As of January 1, 2007 all group lesson payment and reservations will be done as an EFT (Electronic Funds Transfer). This policy applies to all Tiny Tots, Stars of Tomorrow, Advanced Stars of Tomorrow and Jr. High/High School Groups.

T-2/3 & T-1 Students if you have not paid for your class prior to class day you must go to the office first before checking your child in the class. A student not on the roll or without a receipt for the class will not be allowed to participate.

Full session participants only. No drop-ins. No credits for missed classes. Classes will not be pro-rated for partial session participants. Credit will be given for rainouts, be sure to call the club that day and check the recording. We cancel classes one hour prior to class time if it is raining. Credit will only be given for classes that are canceled by the Murrieta Tennis Club.

GROUP EFT LESSON PAYMENT

The Murrieta Tennis Club reserves the right to change the amount of the group lessons, given thirty (30) days written notice. Any failure to make payments of the monthly installments and charges due will cause your child to be dropped from the class immediately. And the full amount remaining shall become immediately due and payable. Acceptance of any payment after default will not release member from any obligations under this Contract. You agree to pay court costs and reasonable attorney's fees involved in collecting amounts owed under this Contract, as determined by the court. If your EFT comes back as a return you will be notified via telephone.

Electronic Funds Transfer (EFT). A customer using Electronic Funds Transfer has authorized his or her bank to pay for group lessons on the 5th day of each month. If funds cannot be collected on that date, the member will be charged a service fee by the Club in addition to any service fee which the member's bank may charge, and the member will be responsible for payment of the amount due.

Finance Charge. If full payment of the member's account is not received by the 5th of the month, any balance unpaid on the tenth of the month will be subject to a finance charge of 10%. The finance charge will be added to the unpaid balance after deducting payments and before adding current charges.

Return Charge. There will be a \$15.00 charge for any returned checks, debit or credit card returned for any reason.

REFUND/CREDITS

Credit are only given for rain outs, only if we cancel due to rain. It is your responsibility to call and check on class status. Credits for injury/illness must accompany a doctors note to receive a credit. All Credits are applied to your account directly. A refund if need will be sent out within 10 days of receiving the credit.

RULES AND REGULATIONS:

All customers and their guests shall abide and fully comply with the Rules and Regulations of the Murrieta Tennis Club.

CANCELATION OF GROUP LESSON EFT:

Voluntary Cancellation. An account who is in good standing and current in all obligations to the Murrieta Tennis Club may cancel at any time by completing a Group Lesson EFT Form for Additions and Changes at the Club or by submitting written notice. All additions/changes must be received by the last day of the month to be effective the following month. We do not make changes on the current month or give refunds for the current month. NOT ATTENDING CLASSES AT THE CLUB AND/OR NONPAYMENT OF GROUP LESSONS ARE NOT METHODS OF CANCELING JR GROUP LESSON EFT.

Involuntary Cancellation. The Murrieta Tennis Club shall have the right, with or without cause, to revoke any lesson taking privileges at any time. Any account which is thirty (30) days past due may at the sole option of the club be terminated, in which case the customer shall be responsible for charges through the date of cancellation.

Re-activation Policy. If account is in good standing, they will need to fill out a new form to start attending classes. If account was terminated for non-payment on account the back charges prior to re-starting classes will be need to collected.

Hold and/or Leave of Absence Policy. Hold/Leave of absence is allowed with a written letter or a Group Lesson EFT Form for Additions and changes completed.

LIABILITY WAIVER AND RELEASE AND ASSUMPTION OF RISK

The undersigned recognizes the use of the equipment and the facilities of the Murrieta Tennis Club involves a risk of physical injury, including that caused by the negligence of him/herself of Murrieta Tennis Club, its agents and employees. The undersigned hereby agrees to assume the risk of injury in its entirety regardless of the cause. You (Buyer, each member and all guests) agree that if you engage in any physical exercise or activity or use any Murrieta Tennis Club facility or any of its affiliates or related entities, you do so at your own risk of any and all injury and/or damage while engaging in any physical exercise equipment (mechanical or otherwise), the locker room, sidewalk, parking lot, adjoining parking lots, stairs, lobby area, or any equipment at Murrieta Tennis Club. Member agrees to assume the risk in his or her participation in any activity, class program, instruction, or Murrieta Tennis Club sponsored event. You agree that you are voluntarily participating in the activities and using the Murrieta Tennis Club facilities and premises and assume all risk of injury, illness, damage, or loss to you and/or your property that might result from the negligence of Murrieta Tennis Club or any of its affiliates, employees, agents, representatives, successors, and assigns.

You agree on behalf of yourself (and all of your personal representative, heirs, executors, administrators, agents and assigns) to release and discharge Murrieta Tennis Club (and our affiliates, employees, agents, representatives, successors, and assigns) from any and all claims or causes of action (known and unknown) arising out of the negligence of Murrieta Tennis Club or any of its affiliates, employees, agents representatives, successors, and assigns. This waiver and release of liability includes, without limitation, injuries which may occur as a result of (a) your use of the facilities that may malfunction or break, (b) Murrieta Tennis Club's improper maintenance of any exercise equipment or facilities, (c) Murrieta Tennis Club negligent instruction or supervision, including tennis instruction and, (d) you slipping and falling while on or in the facility or any portion of the premises for any reason, including Murrieta Tennis Club negligent inspection or maintenance of its facility. By execution of this agreement, you hereby agree to identify and hold harmless Murrieta Tennis Club from any loss, liability, damage, or cost Murrieta Tennis Club may incur due to your presence at Murrieta Tennis Club facility. You further expressly agree that the foregoing release, waiver, and identity agreement is intended to be a broad and inclusive as permitted by the law and the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
